20/66 APOLOGIES & DECLARATION OF INTERESTS

There were apologies from District Councillor Watkins. There were no declarations of members pecuniary interests.

20/67 MINUTES OF THE MEETINGS HELD ON 27 JULY 2020

Minutes previously circulated and these were accepted and signed as a correct record.

20/68 CLERK'S REPORT AND MATTERS ARISING FROM THE MINUTES

- a. A request had been made for funding to demolish the Sports Pavilion in Robin Lane. Discussions were taking place between the Trustees and Allium Energy regarding funding the project and the Clerk would obtain an update before Council decided the way forward.
- b. The barbed will at Tally Hill had been removed by the Chairman.
- c. It was agreed due to the pandemic to obtain one quote for the installation of the bench at Tally Hill. This would be placed about three quarters the way up just off the right of way and clear of the cut grass area.
- d. The Village Hall thanked the Council for the grant made to assist with Covid-19 requirements. The Clerk had been unable to contact the Playgroup to send their grant, the Chairman would make contact with them.
- e. Permission was granted for the installation of the defibrillator on the Village Hall and the Clerk would now order the unit. It was also agreed that a contribution would be made towards the installation of the power supply.
- f. A grant application had been made to the PFCC for £8,600 for the installation of the VAS signs. Cllr Corden had met with NYCC Highways and they had recommended an additional post and sets of batteries which would be another £1,000. This was agreed.
- g. The Clerk had not heard back from the cell company regarding the future phone mast provision and would chase this up.
- h. The various documents had been submitted to the Extrenal Auditors and these had been accepted. No external audit would be required under the exemption.
- i. The request to metal detect Tally Hill had been granted provided the law on treasure was adhered to and no damage was left.
