## 22/55 CLERK'S REPORT & MATTERS ARISING

- a. A suitable company had been found to undertake the website and it was agreed to engage JKE Web Design if a reference from a n existing parish Council customer proved positive.
- b. The Clerk was still chasing Hambleton DC regarding the TPOs on Haverbrakes Lane and Tally Hill.
- c. The grass cutting would continue with last year's contractor for this season. The Clerk and Chairman had inspected all the areas in the village and this would be put out to tender in September following agreement of the Council to the new tender documents
- d. The work to remove the Paddock Close willow tree and grind out the stump was awaited.
- e. The registry of the green spaces would now take place as the grass cutting map had been finalised.
- f. Cllr Phillips would arrange for the spare bench to be refurbished and placed outside the children's play area looking into the area.
- g. The Clerk still needed to write to Kevin Hollinrake MP regarding the lack of mobile phone coverage in the village due to the suspension of the planned mast.
