# 22/81 APOLOGIES & DECLARATION OF INTERESTS

There were no apologies as all Parish Councillor were present. There were no declarations of members pecuniary interests.

# 22/82 MINUTES OF THE MEETING HELD ON 5 SEPTEMBER 2022

The minutes had been previously circulated, and these were accepted and signed as a correct record. It was agreed that the Clerk would circulate draft minutes within a week of each meeting.

### 22/83 PUBLIC FORUM

Matters raised were grass cutting, wildflower verges and an update on the rights of way.

#### 22/84 REPORTS FROM COUNCILLORS

- a. County Councillor Taylor reported that a road sweep had been requested and carried out. He has given a grant from his locality budget to assist the community shop with their planning application. The budget at NYCC was currently being set, a 1% rise in inflation results in a £1m additional spend. 50% of the budget goes on adult social care.
- b. District Councillor Watkins was not present.

### 22/85 CLERK'S REPORT & MATTERS ARISING

- a. The website design with JKE Website Design was ongoing.
- b. The Clerk had chased up Hambleton DC regarding the TPOs on Haverbrakes Lane and Tally Hill and would chase this up again.
- c. The works to the Paddock Close willow tree was delayed due to a Tree Preservation Order and this application would be completed next week.
- d. The green areas now identified on the grass cutting tender map would be used to register the areas with the Land Registry. It was agreed due to the complexity that a solicitor should be engaged to undertake the work.
- e. The refurbished bench at the children's play area had now been installed.
- f. The Clerk had contacted the Head Teacher of the Primary School to ask if the children could choose the layout of the new Tally Hill sign. Cllr Wright would follow this up.
- g. The confirmation of suitable bus stop locations was awaited from NYCC Highways who has passed this to the County Integrated Passenger Team.

- h. The Clerk would check when a request to works on the Leylandii tree at the rear of 4 Horner Avenue had been made.
- i. The Clerk had checked with Hambleton DC regarding the situation with the Neighbourhood Plan and a response was awaited.
- j. NYCC Highways had responded regarding the request for speed tubes on Tollerton Road to assess whether a request for a 20mph zone outside the school would be made. A request would need to be made to the North Yorkshire Police Traffic Bureau.
- k. The Mended Drum car park had reopened.
- I. NYCC Highways had apologised for the delay in dealing with the request for additional grit bins and now required locations and photographs so they could deliver the bins.

#### 22/86 GRASS CUTTING CONTRACT

The residents' group had failed to come up with a consensus on the grass cutting management plan. The parish would now be consulted through the Huby Voice to ascertain more views and the matter would be decided at the next meeting.

#### 22/87 DEMENTIA FRIENDLY PARISH

Cllr Dale outlined the support available to the parish and would produce an article for the Huby Voice.

### 22/88 PUBLIC WORKS LOAN

- a. The 100% positive responses to the survey were noted. 130 replies had been received.
- b. It was resolved to seek the approval of the Secretary of State for Levelling Up, Housing & Communities to apply for a PWLB loan of £450,000 over the term of 50 years for the purchase of the community shop at 1 Robin Lane. The annual loan repayments will come to around £22,600. It is not intended to increase the council tax precept for the purpose of the loan repayments.
- **c.** It was agreed that due to the report from the building surveyor that the offer be reduced by £5,000 to cover the remedial works required.
